
CCM Health will continue to be an independent organization focused on our patients and employees.

The following pages will show each individual strategic category, and what CCM Health's goals are are in those categories.




Access to health care is a right of every citizen regardless of the ability to pay. We have a charity care program that allows people below certain income limits to receive discounted or free care through an easy application process.
