Charity Care epwene ngenir murin meinisin pwan ekkoch nenien angei aninis kena ren secondary momon ra kan fen roseno anonganong won taropwenon mochenir usun a tapweto:

A. Charity Care epwene ngeni aramas kena anonganong won an ar family monitonong usun a awewe ngeni ewe Federal Poverty Income Guidelines (FPIG).

- Charity Care epwene ngeni non 100% ika pwe an ewe family monitonong a kan kukun seni ika wewe ngeni ewe FPIG iei
- Charity Care epwene ngeni non ew akisinon wukukun ika pwe an ewe family monitonong a kan kukun seni fan wunungat ewe FPIG iei me pwan kukun seni fan ruwow ewe FPIG iei ren ew imwen family ren 8.
 - Ew 100% akukununon epwene ngeni ika pwe an ewe family monitonong a kan kukun seni fan ruwow ewe FPIG iei (epwe fofor ngen akukununon momon pisekir).
 - Ewe akukununon epwene akukununo seni 1% ren ew me ew 1% an ewe family monitonong a kan watte seni ewe FPIG*2 (fofor ngeni awukukunon monitonong me pwan akukununon momon pisekir)
 - Aramas kena ra anefano ar monitonong repwene fofor ngen ew akukununon momon pisekir ika pwe ar unusen mon pisekir a watte seni \$50,000. Chomongenon pisekir kena

epwene akukununo seni 1/2% ren ew me ew 1% ina ar monitonong a kan watte seni FPIG. Ei repwene eaea ren ar repwe finata ewe awukukun akukununon momon ina ewe chon semwen epwene fofori ren an epwe moni me mwan an aeoeo ngeni ekkena akukununo ngeni ewe nusun ren ar kewe momo.
